

SIX ARRESTED IN HART COUNTY FOR MULTIPLE DRUG CHARGES

On Friday, Kentucky State Police Post 3 Bowling Green received an anonymous drug complaint on Flint Ridge Road in Hart County. Upon arrival, KSP made contact with Joseph Jewell. A search of the residence resulted in locating three one step methamphetamine labs, several precursors to manufacture methamphetamine, drug paraphernalia, marijuana, and a firearm. A small child was also located inside the residence and was removed by Hart County Protection & Permanency. A total of six people were arrested without incident. The investigation is ongoing and being led by Trooper Jeremy Smith. Trooper Smith was assisted by Troopers Randy Chambers & Graham Rutherford, Horse Cave Police Officer Bruce Neville, & Hart County Protection & Permanency.
