

Regional cross country meets were Saturday for area high schools.

From class 1A, Region 2:

The men's race saw Green County winning the region. Green County was led by Derrick Troxell

Hancock's Cody Roach won the race. Campbellsville's Nathan Riggs and Micheal Rafferty finished second and third. State individual qualifiers include Cumberland County's Corey Williams, Glasgow's Zack Wheeler and Monroe's County's Joseph Quick. Green County's will be scored as a team at the State meet.

The girl's race also saw Green County winning the meet with Sidney Davis leading the way. Glasgow's Marissa Moore finished second for the Lady Scotties qualifying for state meet.
