August 2, 1981 - The Glasgow Barren County Volunteer Action Center opens on the fourth floor of the Barren County Courthouse. Evelyn Pace and Connie Hart are co-founders. The center matches volunteers with groups needing them.

August 16, 1981 – The new Kentucky Building Code goes in effect with Bobby Wade as the new County Building Inspector. City inspector is Gerald Guinn.
